


134 WAYS THE TALIBAN WAGE WAR ON WOMEN



Executive Summary & Introduction

Afghan Women's Resistance Amid Systematic Erasure

Four years after the fall of Kabul, Femena has documented that the Taliban has issued <u>134 decrees and directives</u> targeting women and girls. These edicts strip away rights in education, employment, healthcare, mobility, and self-expression, dismantling decades of progress. Most recent taliban taliban edicts ban <u>women's voices</u>, <u>windows facing women</u>, <u>women's medical training</u>, and women dining in restaurants with their families.

These are not isolated restrictions. Together, they form a framework of gender apartheid a calculated system designed to remove women from public and political life entirely.

Afghanistan is now the only country on earth to ban girls from schooling beyond grade six and women from universities. Under the "<u>Propagation of Virtue and Prevention of Vice</u>" law, women face harsh dress codes, male guardianship, and even the criminalization of their voices. Those accused of "bad hijab" are abducted, abused, and held without contact with their families.

Despite the danger, Afghan women continue to resist, protesting, organizing, and creating underground networks.

Femena's <u>interviews</u> with detained women activists reveal systematic abuse: torture, sexual violence, solitary confinement, threats against children, and prolonged unlawful detention.

The International Criminal Court has issued arrest warrants for Taliban leaders for gender persecution, an essential precedent that must be expanded.

Summary of Findings

- Loss of Rights: Girls are banned from secondary and university education; women are prohibited from most forms of work, barred from public spaces, and denied freedom of movement without a male guardian.
- **Human Cost:** Forced marriages, suicides, and severe mental health crises have sharply increased, with young women bearing the brunt.
- **Targeted Persecution:** Minority communities, especially Hazaras, Tajiks, and Shias, Sikh face disproportionate brutality.
- **Invisible Suffering:** In rural areas, the absence of media allows the harshest abuses to continue without record or remedy.

Purpose of this Publication

This brief amplifies the voices of Afghan women living under Taliban rule, using first-hand testimonies to reveal the human toll behind the statistics. It calls on the international community to reject normalization of the Taliban regime and to take urgent, concrete action to protect and restore women's rights in Afghanistan. It urges the international community to fund and meaningfully support informal women-led civic initiatives inside the country, whose vital work is diminishing due to a lack of access to funding. These informal groups must be recognized not only for their resilience but also for keeping Afghanistan's civic space alive under Taliban repression.

134 Ways the Taliban Wage War on Women

The Taliban's decrees form a blueprint for the systematic exclusion of women. Categorized below are the major areas of restriction:



Education Bans

Girls are prohibited from grades 7–12 and universities; the closure of private educational centers for women. Women are barred from medical training, one of the few sectors they were allowed to study.



Public Space Bans

Women are forbidden from parks, gyms, and recreational facilities.



Dress Codes

Mandatory full-body coverings; faces must be veiled in public; punishment of male relatives for women's perceived noncompliance.



Employment Restrictions

Women are barred from most government posts, NGOs, and media; female aid workers are dismissed, disrupting humanitarian programs for women.



Mahram Enforcement

Women cannot travel more than 72km without a male guardian and are denied services including healthcare if unaccompanied. Most recently, the Taliban have extended these restrictions by requiring elementary school girls in some provinces to be accompanied by a male guardian.

Analysis

Each edict is part of a deliberate strategy: reduce women's visibility, strip their economic independence, cut off education, and ultimately normalize their absence from society. The religious and cultural justifications provided lack due process and contradict international human rights standards.

Lived Experiences: Voices from Afghan Women

Afghan women speak at great personal risk. Their testimonies reveal the systematic nature of Taliban repression. Grouped by themes, these voices illustrate the human cost of gender apartheid.

1 - Education Bans Equal to Stolen Futures

"With the closure of the university, I could no longer pursue my studies. I was the only hope for my family. Now I am confined within the four walls of our home."

4- Violence, Imprisonment & Mental Health

Abductions, abuse, and trauma have turned Afghan homes and prisons alike into sites of despair and death. Femena's latest report, "Afghan Women in Taliban Prisons," based on interviews with former women detainees, details harrowing accounts of torture, humiliation, and solitary confinement inside Taliban prisons, simply for peacefully protesting or refusing to disappear.

The erasure of women's voices is deliberate, designed to normalize their absence from every corner of Afghan society. While each quote speaks of individual pain, together they reveal a pattern: the erasure of women's futures, the silencing of their voices, and the steady suffocation of their hopes.

Regional Disparities & Systemic Violence

No Province Spared, No Woman Safe

The Taliban's oppression of women is national in scope but varies in form and severity:

- Ethnic Discrimination: Hazara, Tajik, and Shia women face disproportionate harassment, arrests, and denial of aid.
- Urban vs. Rural: Urban women may find limited workarounds or underground schools; rural women face near-total restrictions.
- Media Visibility: In provinces without internet access and media, abuses happen with complete impunity.

Patterns of abuse indicate targeted repression based not only on gender but also on ethnicity, religion, and geography, a multi-layered form of persecution that leaves the most marginalized women in the most danger.

Demands to the International Community

Your Silence is Their Strength

The women whose testimonies fill these pages cannot lobby governments or speak openly without risking their lives. Their demands, conveyed through activists and allies, are clear:

- No Recognition and Normalization of the Taliban Regime: Governments and international bodies must
 withhold recognition of the Taliban regime until all decrees violating women's rights are revoked.
 Diplomatic recognition, participation in the UN, or seating in regional bodies would legitimize a
 system of gender apartheid. States should adopt a unified, binding stance that prevents
 normalization, avoiding the mistakes of the recent Doha process, where Taliban demands dictated the
 exclusion of women. Recognition under such conditions entrenches oppression and undermines
 international human rights norms.
- International Legal Mechanisms for Accountability: Support international legal mechanisms, including the ICC's recent arrest warrants for Taliban leaders, and ICJ avenues, to hold perpetrators accountable for crimes against humanity and systematic gender persecution.

- Fund and Sustain Women-Led Resistance and Survival Networks: Donors must redirect humanitarian and development funding away from Taliban-controlled ministries and toward independent Afghan women-led organizations. These include underground schools, safe houses, health initiatives, and women's media and advocacy networks the last line of defense for girls' education and survival. Secure, discreet funding channels must be created to bypass Taliban oversight, with built-in protections for women activists at risk. Sustained, long-term investment in these networks is essential to preserving a foundation for Afghan women's future.
- Ensure Inclusive and Representative Peace Processes: Key forums and processes about the future of Afghanistan, including the Doha process, must guarantee meaningful participation of women, minorities (Hazara, Tajik, Shia, Sikh), youth, and civil society leaders. International mediators should ensure broad representation and embed gender equality as a non-negotiable principle of any political settlement. A durable peace in Afghanistan is impossible if half the population and entire marginalized communities are silenced. The reality of Afghanistan extends far beyond the Taliban: the women, young generation, and diverse communities that the Taliban's all-male, majority Pashtun cabinet does not represent hold the values, voices, and aspirations of the nation.

This shutdown disproportionately affects women and girls, cutting off access to online schools, remote work opportunities, and vital information sources at a time when most in-person education for women is already banned.
